# National Competitions Officer:

Thank you, I would like to thank all of the clubs that had to do the hard yards with the councils, EBTDC being the first set to the challenge, with great results. Some of the clubs only visited one council for consent making for a tense moment before the start of the event. Massive thanks to Mike Gee-Taylor for running the first 2-day event for the sport, there was a 50/50 split on competitors as to if they would like to do it again. Thanks to the committee for their support even if I wasn't their first choice. Thanks to Tom Baeriswyl for the trophy design and to Derek Smyth for getting them cut out and the stickers printed and to Daniel Howat for sorting out the finishing work that took 4 nights of hell in my house.

Daniel also sorted out the certificates and if you look closely you will see that each certificate is personalised with that competitor's truck on their own certificate and a huge thanks to Rachel Buckthought for getting them all printed.

I took the job on to follow the court case through to see what was going to happen to the sport, from this there are a few remits to give the ENCC more control to stop events or close obstacles if required. The NZFWDA has brought in regulations as a result of their sentencing, I think they are on the right track but taking the control away from the members is not a good thing. Closing off the season early was a hard call, with many hours of phone calls and messages. The outcome did change a few of the top positions as



we started the season with the best 5 out of the 6 rounds, unfortunately with the cancellation of the final round and some competitors who had a dropped an earlier round it had implications on the placings of some competitors. This coming season we are all hoping that we a get a Covid free run and can resort back to 5 out of 6. We have worked hard the season to cut costs as Rachel will explain in her report.

Looking ahead we have 6 rounds already planned for this season with the dates already up on the website and also 2 more for the following season.

I will be standing down as most of you already know, I have taken on the role of Central Zone President and cannot do both, but I am hoping that this will give us as competitors more representation on the NZFWDA Executive. Derek Smyth has put his name forward to take on the role and has already been working behind the scenes to get things moving forward.

We have now got control of Swan and we will be joining the 2 websites together so you will be able to access Swan though the nz4x4trials website. This has all been done at no cost to the Competitions Committee and Marcus will host this on his server at no cost. Daniel Howat has stepped up to help with the website and has been working with Andi and Marcus on the website improvements. I believe this needs to be a fulltime position and we should be looking into this in the immediate future and somebody needs to be updating the website all the time.
